

Hypno-Survivorship Membership: Terms and Conditions

PRACTITIONER AGREEMENT:

The Hypno-Survivorship Program is a support program designed to emotionally support individuals diagnosed with cancer and their loved ones. It must be made clear here that the Hypno-Survivorship Program is not an alternative therapy to the conventional medical treatment of cancer. It is a complementary therapy dealing solely with the client's emotional state and not their medical condition.

Practitioners must take particular care when promoting, marketing and administering this therapy that they do not attempt to promote or offer cures, remedies or personal advice that may directly or indirectly influence the choice of their client's medical treatment as this could be viewed as contravening the Cancer Act 1939 in the UK.

BECOMING A LICENSED PRACTITIONER

The cost of becoming a Licensed Practitioner is a one off fee of £249.95 Sterling paid via PayPal, obviously purchasers from other countries will convert that price into their own currency.

To become a Licensed Hypno-Survivorship Practitioner you must agree to the following:

- 1) Therapists must have been in Practice for a minimum of 2 years; however, exceptions can be made depending on the particular therapist's circumstances. I.e. Nursing Staff / Medical Practitioners who all already working in that field.
- 2) Therapists must have their PLC Insurance in place.
- 3) Therapists must send through their Hypnotherapy Qualifications within 28 days of purchase.

CONDITIONS OF BECOMING A LICENSED HYPNO-SURVIVORSHIP PRACTITIONER.

- 1) The Hypno-Survivorship program is designed for qualified therapists and its ethos should be strictly adhered to at all times, no responsibility can be taken by the vendor for way the program is administered by its therapists.
- 2) Any Marketing materials/templates received in the Hypno-Survivorship Pack are for reference only and each practitioner should assess their suitability, legality and message based on their location/country.

No responsibility will be accepted for advertising/marketing materials or messages that infringe the trading law/trading standards of the said practitioners district.

- 3) All images on the marketing materials are copyrighted by the photographer and the buyer will have to re purchase the right to use those images if they so wish, instructions on images used and where they can be purchased is contained in the practitioners pack.
- 4) Licenses are per individual and NOT by centre. Licensed Practitioners agree to respect other practitioners and their areas of operation. If a practitioner is found to have been deliberately misleading during the application process their license will be withdrawn.

Practitioners are not permitted to use either the Hypno-Survivorship logo or publicity to promote their own versions of this program. It must be made clear to potential clients which method they are agreeing to undertake.

Licenses are not permitted to sublicense the use of the Hypno-Survivorship Emotional Support Program.

5) Once the package has been purchased, it will be issued via electronic/digital means in the form of a .Zip folder with a username and password. Once received and the purchaser is satisfied it is complete. The financial transaction is complete.

It is the responsibility of the practitioner to satisfy themselves that they meet the local authority (Country/State/County) requirements in the area they wish to advertise and deliver the Hypno-Survivorship program contents.

No refunds, financial compensation or monetary returns will be made under any circumstances to any purchaser, unless it can be proved the program and its contents were not fully received. This also includes no refunds or reimbursements any costs incurred to the buyer with regard to any training, marketing, promotional materials, travel or any other financial costs incurred by the purchaser of the Hypno-Survivorship program or in association with the Hypno-Survivorship program. It is completely up to the purchaser's discretion how they choose to build and promote their business and implement the Hypno-Survivorship program into their practice. All materials supplied in the pack are for guidance and reference purposes only.
